The Pharmaceutical Society of New Zealand Incorporated is the professional body for New Zealand pharmacists. We provide professional support, education, training and career development for all pharmacists, assisting and enabling them to deliver best practice and professional services for the New Zealand public. It is a voluntary society.

What does my PSNZ fee get me?

- Membership period is January 1 - December 31 annually.
- Individualised ENHANCE programme support and review of your CPD records before submission to Pharmacy Council for audit.

The Pharmacy Council requires all pharmacists be participating in ENHANCE for recertification each year. PSNZ is accredited by Council to provide the ENHANCE programme which allows pharmacists to meet all the Pharmacy Council requirements for annual recertification.

- College of Pharmacists membership is free to all **full** members - **non PSNZ members \$155.00.**
- Expert practice advice and support from our team of pharmacists.
- Regular practice related articles in The e-EDGE newsletter.
- Library and Pharmacy Press information services.
- Access to the “members’ only” section of the PSNZ website for current practice and regulatory advice.
- Representations to Government and other organisations on issues affecting the practice of pharmacy.
- The right to use the MPS/FPS designation.
- Being part of the organisation that represents the interests of all pharmacists.

How do I join PSNZ?

Simply complete the application form, return it to PSNZ with your payment details and you will be sent an introduction letter including a password to the “members’ only” section of our website www.psnz.org.nz

Please note that although your full membership fee covers ENHANCE and the NZ College of Pharmacists, you must also enrol in the ENHANCE Programme and sign the NZ College of Pharmacists declaration to join the College.

The ENHANCE programme supports members by providing at no cost:

Access:

- to all required ENHANCE material and updates.
- to training — both group workshops and one on one training if required.

Support Individual support when required at any time including:

- One on one learning plan assessment and feedback.
- Assistance with documentation for NZCP courses.
- Pharmacy Council audit.

Costs for Non Members are:

NZ College of Pharmacists

The NZ College of Pharmacists is an excellent source of courses and education modules suitable to be used to meet the ENHANCE goals. Membership of PSNZ Inc also includes the cost of membership to the College of Pharmacists which enables members to access NZCP courses at discounted member's rates. The ENHANCE programme provides a link for NZCP courses with your ENHANCE programme plan, and a suggested CPD Record Sheet guide for any NZCP or PSNZ course you complete.

What option should I go for?

There are two membership criteria:

1. **Full Membership** with all the benefits mentioned above for \$428 (incl GST) per annum, or;
2. A **Limited Membership** for those pharmacists who are;
 - retired
 - overseas
 - or non-practicing

This membership includes subscription to The e-EDGE newsletter, access to the library and Pharmacy Press and allows you to keep your MPS/FPS designation. This option costs \$101 per annum (incl GST). Please note the Limited membership does not include the full training and support, ENHANCE Programme or the College membership.
